### SUMMARY

#### Glendale Water Supply Improvement Project

Truckee Meadows Water Authority (TMWA) is accepting sealed bids for all labor, materials, equipment, and incidentals required for the removal and reconstruction of the existing diversion to the Glendale Water Treatment Plant. Work includes demolition and removal of existing structure and construction of a new low profile roughened channel weir complete with fish passage structure, new fish screens, juvenile fish return, sediment ejector, hardening and reconstruction of the adjacent Eastman Ditch, landscaping, and environmental restoration. Construction activities will include dewatering of the river in the construction area. Pressure grouting of certain sections of the river bed associated with weir construction will also be required.

TMWA will provide and has selected a consultant to provide backfill, compaction, and soils related testing and special inspection services. TMWA will provide horizontal and vertical survey points. The Contractor shall provide any additional necessary surveying.

**FEDERAL FUNDING** has been provided through the Nevada Department of Environmental Protection (NDEP) through the Drinking Water State Revolving Fund. Therefore, MBE/WBE goals have been established for this project. The policy goal of the MBE/WBE Programs is to assure that minority business enterprises (MBE) and woman business enterprises (WBE) are given the opportunity to participate in contract and procurement for supplies, construction, equipment and services under any EPA grant or cooperative agreement. The minority Business Enterprise (MBE) goal set for this project is 6.28%. The Women Owned Business Enterprise (WBE) goal is 15.51%. The goal applies to all contracts/procurement for supplies, construction equipment, and services. Below is a list of anticipated Trades and Material Suppliers that may be necessary on the project.

Although this project is valued over \$250,00, due to the Federal Funding, this project is exempted from NRS 338.147

**A DOCUMENT DEPOSIT** is required due to Homeland Security issues. TMWA is responsible to ensure that Plans and Specifications are returned after a project is bid. Contractors are required to return the complete plans and specifications to TMWA within thirty (30) days of project bidding.

A \$250.00 ("Homeland Security Document Deposit") will be required the first time a contractor bids on a project. The funds will be deposited into a TMWA account. If the plans and specifications are returned to TMWA, the funds will be retained for future projects. Interest will accrue for the period of time the deposit is held. Your deposit and interest are refundable at any time upon written request.

If the plans & specifications are not returned to TMWA, your deposit will be retained by TMWA and you will be required to submit a new deposit for the next project. If you have more than one set of plans that are not returned, TMWA will bill you for the balance at \$250.00 a set and you will not be permitted to bid on future projects until your balance is paid and a new \$250.00 deposit is submitted to TMWA. Be sure to include your company name, phone number, fax number, and address on your check.
