



Water Rates Schedule

The Truckee Meadows Water Authority (TMWA) Board of Directors approved the following Rates, Charges, and Fees effective with your June bill.

The adjustments are necessary for TMWA to remain financially stable while continuing its commitment to maintain and improve the water system for the benefit of customers.

New Rates and Your Bill

You will notice that your bill looks different this month. This is because some of the water you used is charged under the old rate and some under the new rate.

The usage that was billed under the old rate is noted as “OLD,” designated as ❶ in the bill samples below. The usage billed under the new rate is noted as “NEW,” designated as ❷ in the bill samples below. For flat rate customers, this is shown on the front of the bill. For metered customers, this applies to both the “Customer Charge” and the “Water Usage Charge,” which is shown on page 2 of your bill. Future bills will calculate charges according to the new rate only.

FIRE PROTECTION SERVICE: Rate Schedule FPS

Applicability

Delivery of water under this Rate Schedule is available for fire protection purposes to any Service Property through Customer-owned Fire Facilities as defined in the Rules. Fire Facilities owned by Local Governments within the Authority’s retail service territory are excluded from this Rate Schedule.

Customer Charge

The charge for delivery of water per Billing Period for this service shall consist of a monthly Customer Charge computed at \$ 4.60 per inch of the nominal diameter of the Service Pipe.

NON-POTABLE WATER SERVICE: Rate Schedule NPS

Applicability

Delivery of water under this Rate Schedule is available, at the sole discretion of the Authority, to Customers for Non-Potable uses of water including but not limited to, dust control, earth compaction, irrigation or any other Non-Potable use from non-treated or treated water sources of supply managed by the Authority.

Delivery of water under this Rate Schedule is available, at the sole discretion of the Authority, to Customers for interruptible water deliveries.

LARGE VOLUME RESALE SERVICE: Rate Schedule LVS

Applicability

Large Volume Resale Service is applicable to water companies for resale within Wholesale Service areas as established in Rule No. 10.

FIRM STANDBY & PARTIAL REQUIREMENTS:

Rate Schedule FSPR

Applicability

Firm Standby/Partial Requirements Service is available, at the sole discretion of the Authority, to water companies for resale within Wholesale Service areas as established in Rule No. 10, and where another Rate Schedule is not specifically applicable. This Rate Schedule is limited to Customers where: (1) none of their water requirements are supplied by the Authority and the Authority must standby for this service or, (2) only a portion of their normal daily water requirements are supplied by the Authority and the Authority supplies partial water requirements.

DITCH IRRIGATION SERVICE: Rate Schedule DIS

Applicability

Applicable to Irrigation Service only by any Customer described below in the amount of their respective water right(s). Service is to be taken at one point, or alternately at two points, directly from a ditch operated by the Authority and shall not include any service from the Authority’s reservoirs, purification basins, or distribution system.

Customer Charge

The charge for delivery of water shall be payable in advance and shall be at the rate of \$ 16.04 for each acre foot for which application is made for the five month irrigation season. This charge may be prorated based on the number of days in the 160 day period for which water is requested to be delivered.

Regional Water Management Fee

The following applies to All Rate Schedules:

Late Charge 5% of any amount in arrears from previous billings.

Truckee Meadows Water Authority is a not-for-profit, community-owned water utility, overseen by elected officials and citizen appointees from Reno, Sparks, and Washoe County.

RESIDENTIAL METERED WATER SERVICE:

Rate Schedule RMWS

Applicability

Delivery of water under this Rate Schedule is available for all purposes to any single family residential dwelling served through a separate Service Connection. This Rate Schedule is mandatory for delivery of water to residential Customers in newly constructed residential buildings which are occupied for the first time on or after July 1, 1988; and for residential Customers who receive a Meter pursuant to Rules 2 and 6.

Effective March 1, 2002, any single family residential Customer making a first-time request for residential delivery of water at an existing RFWS or SUFR and any previous single family residential Customer requesting a change of delivery of water to a different single family residential existing RFWS or SUFR, will be required to pay the metered rate pursuant to this Rate Schedule. For previously Unmetered Service Property(ies), the Authority will install Meter Facilities as soon as practicable, with costs to be borne by the Authority in accordance with Rule 6.

Backflow Charge: This charge applies to single family residential Customers where the Service Property has a backflow prevention assembly maintained by the Authority. The monthly charge applied per Billing Period for operations, maintenance, service and annual testing associated with the backflow prevention assembly is \$ 4.50.

MULTIPLE-UNIT RESIDENTIAL METERED WATER SERVICE:

Rate Schedule MMWS

Applicability

Delivery of water under this Rate Schedule is available for all purposes to any multiple-unit residential Customer in multiple-unit complexes including apartment complexes, mobile home parks and two or more detached single family dwellings metered in accordance with Rule 6. This Rate Schedule is mandatory for delivery of water to residential Customers in newly constructed multi-tenant residential buildings occupied for the first time on or after July 1, 1988; and for multiple-unit residential Customers who have received a Meter pursuant to Rules 2 and 6.

- \$15.70 for a 3/4" Meter Size
- \$17.30 for a 1" Meter Size
- \$19.60 for a 1-1/2" Meter Size
- \$22.80 for a 2" Meter Size
- \$25.90 for a 3" Meter Size

- \$34.50 for a 6" Meter Size
- \$40.00 for a 8" Meter Size
- \$47.10 for a 10" Meter Size

Commodity Charge per Billing Period for each Tier, all Meters Sizes

- Tier 1 – First 4,000 Gallons per month \$1.72 per 1,000 Gallons (times number of units)
- Tier 2 – All excess Gallons at \$2.78 per 1,000 Gallons

METERED IRRIGATION SERVICE: Rate Schedule MIS**Applicability**

Delivery of water under this Rate Schedule is mandatory for separately Metered Irrigation Service.

- \$15.70 for a 3/4" Meter Size \$29.80 for a 4" Meter Size
- \$17.30 for a 1" Meter Size \$34.50 for a 6" Meter Size
- \$19.60 for a 1-1/2" Meter Size \$40.00 for a 8" Meter Size
- \$22.80 for a 2" Meter Size \$47.10 for a 10" Meter Size
- \$25.90 for a 3" Meter Size

Commodity Charge per Billing Period, all Meter Sizes

- Off-Peak (10/01 – 05/31). \$2.78 per 1,000 Gallons
- On-Peak (06/01 – 09/30). \$3.25 per 1,000 Gallons

RESIDENTIAL FLAT RATE WATER SERVICE: Rate Schedule RFWS**Applicability**

Delivery of water under this Rate Schedule is available for residential purposes for use in single family dwellings, condominiums, and apartment complexes where each unit is served through a separate Service Connection. Customers receiving delivery of water under either of the residential metered water or multiple-unit flat rate service Rate Schedules are excluded from this schedule.

SMALL UNIT FLAT RATE SERVICE: Rate Schedule SUFR**Applicability**

Delivery of water under this Rate Schedule is available for single family residence(s) on a Service Property(ies) with lot size 3,000 square feet or less served individually through a separate 3/4" Service Connection. Customers receiving delivery of water under either of the residential metered water or multiple-unit flat rate service Rate Schedules are excluded from this Rate Schedule.

- \$ 32.90 for Service Connection

MULTIPLE-UNIT RESIDENTIAL FLAT RATE SERVICE: Rate Schedule MRFS**Applicability**

Delivery of water under this Rate Schedule is available for residential purposes to any Customer for use in multiple-unit residential complexes, including apartment complexes, mobile home parks, and two or more detached single family dwellings served through a single Service Connection with separate Irrigation Service at the same Service Property. Customers receiving delivery of water under either of the residential metered water service Rate Schedules are excluded from this Rate Schedule.

Rate Schedule MRIS

Applicability

Delivery of water under this Rate Schedule is available for residential purposes to any Customer in multiple-unit residential complexes, including apartment complexes, mobile home parks, and two or more detached single family dwellings, served through a single Service Connection without separate Irrigation Service at the same Service Property. Customers required to receive delivery of water under either of the RMWS or MIS Rate Schedules are excluded from this Rate Schedule.

Commodity Charge per Billing Period for each Tier, all Meter Sizes

- Tier 1 \$1.72 per 1,000 gallons
- Tier 2 \$2.78 per 1,000 gallons
- Tier 3 \$3.25 per 1,000 gallons
