INTRICATE LOCAL SYSTEM HAS MANY WATER PURVEYORS

What is a water purveyor?

A water purveyor is an entity, or business, that provides water to your home or business. Most purveyors own a network of storage tanks, pumps and pipes designed to distribute water to customers. A purveyor may or may not own treatment plants or wells. Local water purveyors are organized in a variety of ways including:

- private, investor-owned utilities
- water cooperatives or users associations
- county or municipal water utilities
- general improvement districts

Who is my water company?

Of course, the company who sends you a bill for your water service is your water company, but that may not tell the whole story. In the Truckee Meadows area, there are several different types of entities providing water service through an intricate water distribution system. Does your water company treat water? Does it buy treated water wholesale? Where does your purveyor get the water they provide? Answers to these questions will give you a better understanding of where the water you use every day comes from and what company treats and delivers it.

What is Truckee Meadows Water Authority's role in the local water system?

Truckee Meadows Water Authority (TMWA) is a not-for-profit, community-owned water utility, overseen by elected officials and citizen appointees from Reno, Sparks and Washoe County. TMWA has a workforce of more than 170 professionals. We ensure the around-the-clock treatment, delivery and availability of high-quality drinking water for more than 330,000 residents and businesses of the Truckee Meadows.

TMWA works to provide high-quality drinking water throughout our community. At TMWA, we are always working to ensure clean and reliable water for all of our customers - the residents and businesses we serve directly and those served by water purveyors that receive treated water from us.

Through highly-efficient treatment plants, TMWA provides water to the majority of residents in the Truckee Meadows. TMWA also provides treated water to most other local water purveyors. Entities, such as Sun Valley General Improvement District and Washoe County, purchase some or all of their water from TMWA and then store water in their own storage tanks and deliver it to their customers.

Where does TMWA get its water?

The majority of the water TMWA delivers comes from the Sierra Nevada snowpack, which provides runoff to Lake Tahoe and travels the Truckee River. TMWA's Chalk Bluff and Glendale facilities treat and distribute high-quality drinking water to the community. After treatment, the water is ready for delivery directly to TMWA's customers and to other local water purveyors. Donner Lake, Independence Lake, Boca Reservoir and Stampede Reservoir allow TMWA to manage through a nine-year drought, one year longer than the longest drought on record.

If TMWA provides the water, does that mean they set my water rates if I am not a TMWA customer?

No. We do *not* set the rates of other water purveyors who purchase water from us. TMWA sets rates only for our customers.

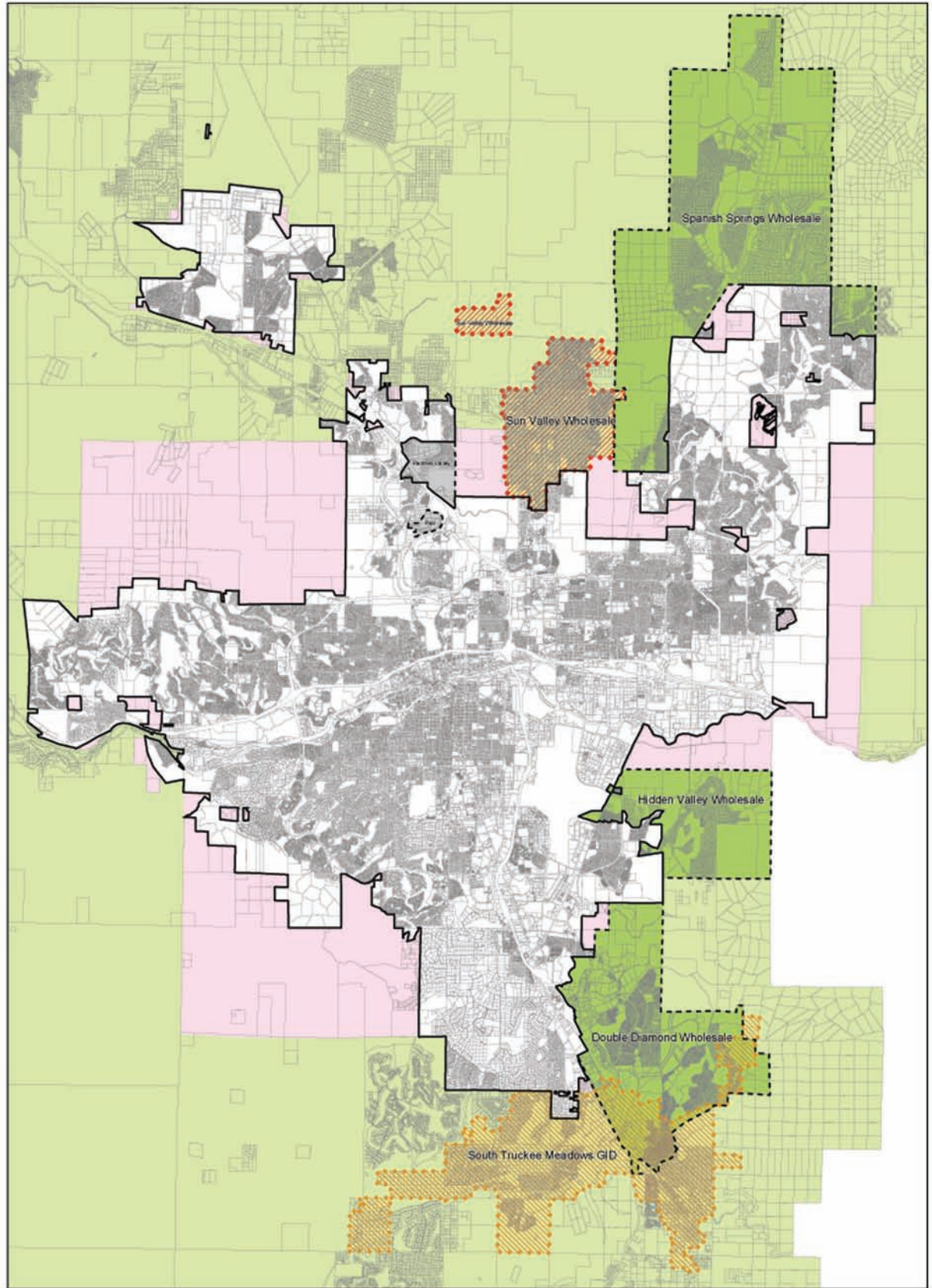
