**PROJECT SCOPE:** Truckee Meadows Water Authority (TMWA) is accepting sealed bids for all labor, materials, equipment, and incidentals required for the Innovation Well Phase 1 – Drilling and Construction. The Site of Work is located in Reno, Nevada. The Work consists of drilling and constructing a production well on TMWA property.

TMWA also reserves the right to waive informalities. Bids will be evaluated as prescribed in Nevada Revised Statute 338.147.
