PROJECT SCOPE: Truckee Meadows Water Authority (TMWA) is accepting sealed bids for the Donner Dam Repairs. The Site of Work is located at Donner Lake in Nevada County, State of California. The work consists of all labor, materials, equipment, and incidentals required for the repair of deteriorating concrete surfaces on the Donner Lake outlet facility (known as Donner Dam). Work to include: surface preparation of deteriorated concrete and concrete reinforcement, application of specified primers and bonding agents, application of specified top-coat materials, and painting of various metal surfaces. The sensitive nature of the surrounding environment will require extensive best management practices to capture all construction debris in order to prevent migration of the debris into the immediate surroundings.
