PROJECT SCOPE: Truckee Meadows Water Authority (TMWA) is accepting sealed bids for all labor, materials, equipment, and incidentals required for the 2016 Fiberglass Tank Relining project. The Site of Work is located in the Cities of Reno and Sparks located in Washoe County, Nevada. The Work consists of relining four (4) fiberglass reinforced polymer storage tanks for the storage of liquid sodium hypochlorite at a concentration of 12.5% at three (3) TMWA water treatment locations. The four tanks to be relined consist of two (2) 8,200-gallon tanks and two (2) 460-gallon tanks.

TMWA will provide access to power (120 VAC), water, and parking.

Contractor to provide portable restrooms, at its discretion, at locations where there are no existing restroom facilities.

Contractor will furnish, provide, install, and remove all scaffolding as required for repairs.

TMWA will accept and entertain bids from only those Bidders in attendance. <u>NO EXCEPTIONS MADE</u>. A mandatory site visit will be required immediately following the pre-bid meeting.

> 3) Final Completion by sixty-five (65) calendar days following the issuance of the Notice to Proceed.

TERM OF THE CONTRACT: Commences on the issuance of the Notice to Proceed through June 15, 2016 with the right to renew for five (5) additional one-year periods upon mutual agreement between the parties.
