RANGE FOR ENGINEER'S ESTIMATE: \$140,000.00 - \$175,000.00

PROJECT SCOPE: Truckee Meadows Water Authority (TMWA) is accepting sealed bids for all labor, materials, equipment, and incidentals required for the Zolezzi PRS & STMGID Well #1 Drain Line Addition. The Site of Work is located in Reno, Washoe County, Nevada. The Work consists of the existing pressure regulating station demolition, water main installation, removal and installation of pipe/fittings within an existing subsurface vault, construction of storm drain and manhole, and miscellaneous pavement and site restoration.

The Contractor shall retain the services of a consultant to provide backfill and compaction testing.

The Contractor shall provide any necessary surveying.

Project Control provided by Truckee Meadows Water Authority.

BID SUBMITTAL: Sealed bids must be submitted to TMWA by mail to P.O. Bids received after the date and time set for receipt will be **REJECTED**.

BID OPENING: **March 22, 2016, at 11:05 a.m.** at the TMWA Conference Room, 1355 Capital Blvd., Reno, NV 89502. TMWA reserves the right to reject any or all bids, including without limitation the right to reject any or all nonconforming, non-responsive, unbalanced, or conditional bids, and to reject the bid of any bidder if TMWA believes that it would not be in the best interest of TMWA to make an award to that bidder. TMWA also reserves the right to waive informalities. Bids will be evaluated as prescribed in Nevada Revised Statute 338.147.

ANTICIPATED START DATE: On or before April 7, 2016.

COMPLETION DEADLINE: Eight (80) days following the Notice to Proceed.

Contract Documents/Specifications. Proposals must be submitted on the stapled bid proposal package to be considered a responsive and responsible bid. Truckee Meadows Water Authority will not consider a Bid received if there is an omission of or failure to complete any portion of the required documents prior to the time of Bid Opening. Do not submit the entire bid book. Each bid shall be accompanied by a certified or cashier's check or bid bond in the amount of not less than five percent of the amount bid in the proposal. It is each bidder's sole responsibility to ensure that they have received all addenda prior to submission of their bid.
