**PROJECT SCOPE:** Truckee Meadows Water Authority (TMWA) is accepting sealed bids for all labor, materials, equipment, and incidentals required for the Fleish Penstock and Highland Inverted Siphon Structural Lining project. The Site of Work is located in Verdi and Reno, Nevada. The Work consists of cleaning, preparation, and structural lining of large-diameter steel pipes. The first site includes approximately 360 linear feet of 96-inch diameter riveted steel, and a second site includes approximately 430 linear feet of 54" diameter welded steel pipe. The liner material shall be monolithic and applied to a uniform design thickness to ensure strength sufficient to resist all loads applied both internally and externally without relying on the surrounding soil or deteriorated existing pipe for support.

**MANDATORY PRE-BID CONFERENCE:**           **None required.**

**BID SUBMITTAL:** Sealed bids must be submitted to TMWA by mail to P.O. Box 30013, Reno, Nevada 89520-3013 or in person to 1355 Capital Boulevard, Reno, NV 89502, and must be **RECEIVED BY TMWA NOT LATER THAN 11:00 A.M.** on **November 3, 2015**. Bids received after the date and time set for receipt will be **REJECTED**.

**BID OPENING:** **November 3, 2015, at 11:05 a.m.** at the TMWA Conference Room, 1355 Capital Blvd., Reno, NV 89502. TMWA reserves the right to reject any or all bids, including without limitation the right to reject any or all nonconforming, non-responsive, unbalanced, or conditional bids, and to reject the bid of any bidder if TMWA believes that it would not be in the best interest of TMWA to make an award to that bidder. TMWA also reserves the right to waive informalities. Bids will be evaluated as prescribed in Nevada Revised Statute 338.147.

**ANTICIPATED START DATE:** Before November 16, 2015.

**COMPLETION DEADLINE:** Thirty Seven (37) days following Notice to Proceed.

**PLANS AND SPECIFICATIONS:** Plans are not applicable to this project and Specifications are included in the Bid Documents found on TMWA's website.

Bidders are to complete all Bid Submittal Forms, contained on pages 2-19 in the Bid Proposal Form Section of the Bid Documents. The complete Contract Documents must be submitted to comprise a responsive and responsible bid. Each bid shall be accompanied by a certified or cashier's check or bid bond in the amount of not less than five percent of the amount bid in the proposal.
