

**INVITATION TO BID

Juniper Hill Road 19" Main Replacement**

RANGE FOR ENGINEER'S ESTIMATE: \$571,000.00 - \$704,900.00

PROJECT SCOPE: Truckee Meadows Water Authority (TMWA) is accepting sealed bids for all labor, materials, equipment, and incidentals required for the Juniper Hill Road 19" Main Replacement. The Site of Work is located Reno, Nevada. This project involves installation of approximately 1,740 linear feet of new 12" and 6" diameter potable water main in Juniper Hill Road to replace existing aging pipes. Associated work includes a normally closed valve connection to an existing parallel main with an orifice bypass, reconnection of existing services and hydrants, and paving. Slurry-filling approximately 8,800 linear feet of existing 24-inch, 19-inch, and 4-inch diameter mains to be abandoned as a result of this work is also included.

TMWA will provide and has selected a consultant to provide backfill and compaction testing.

The Contractor shall provide any necessary surveying.

TMWA to provide Project Control.

MANDATORY PRE-BID CONFERENCE: NOT REQUIRED FOR THIS PROJECT.

BID SUBMITTAL: Sealed bids must be submitted to TMWA by mail to P.O. Box 30013, Reno, Nevada 89520-3013 or in person to 1355 Capital Boulevard, Reno, NV 89502, and must be **RECEIVED BY TMWA NOT LATER THAN 10:00A.M.** On **November 1, 2016**. Bids received after the date and time set for receipt will be **REJECTED**.

BID OPENING: **November 1, 2016, 10:05 a.m.** at the TMWA Conference Room, 1355 Capital Blvd., Reno, NV 89502. TMWA reserves the right to reject any or all bids, including without limitation the right to reject any or all nonconforming, non-responsive, unbalanced, or conditional bids, and to reject the bid of any bidder if TMWA believes that it would not be in the best interest of TMWA to make an award to that bidder. TMWA also reserves the right to waive informalities. Bids will be evaluated as prescribed in Nevada Revised Statute 338.147.

ANTICIPATED START DATE: On or before November 17, 2016.

COMPLETION DEADLINE: Forty-Three (43) days following Notice to Proceed.

The cost for all bid documents is non-refundable. A \$250.00 deposit is required due to Homeland Security issues before any Bid Documents may be purchased. Complete plans and specifications must be returned to TMWA within thirty (30) days of Bid Opening or the deposit will be forfeited.

The bid proposal package comprised of the: Bid Bond, Bid Schedules, Local Preference Affidavit (if applicable) and Acknowledgement and Execution is stapled and found in the inside front cover of the

Contract Documents/Specifications. Proposals must be submitted on the stapled bid proposal package to be considered a responsive and responsible bid. Truckee Meadows Water Authority will not consider a Bid received if there is an omission of or failure to complete any portion of the required documents prior to the time of Bid Opening. Do not submit the entire bid book. Each bid shall be accompanied by a certified or cashier's check or bid bond in the amount of not less than five percent of the amount bid in the proposal. Addenda, if any, shall be posted on the TMWA web-site at http://www.tmwa.com/about_us/doingbusinesswithtmwa/. It is each bidder's sole responsibility to ensure that they have received all addenda prior to submission of their bid.
