## RANGE FOR ENGINEER'S ESTIMATE: \$170,000.00 - \$190,000.00

**PROJECT SCOPE**: Truckee Meadows Water Authority (TMWA) is accepting sealed bids for all labor, materials, equipment, and incidentals required for the Verdi Dam Repairs – 2014-2015 project. The Site of Work is located at Verdi, Nevada. This project entails "in-kind" repairs to TMWA's hydroelectric dam on the Truckee River south/southwest of Verdi, Nevada. The structure has been in existence since the early 1900's, and it provides a source of water to TMWA's Verdi Hydroelectric Facility.

The existing structure on the downstream face of the dam will be repaired. The structure consists of a timber frame structure which holds river rock in compartments or bays across the width of the river. The repair work consists of replacement of identified timber elements including decking, vertical uprights, and splash boards.

The Fish Ladder element of the structure will also be repaired. This includes timber replacement and repairs to concrete walls which are part of the fish ladder structure.

The contractor will also remove sediment that has collected on the upstream face of the dam. It is expected that this can be accomplished with a track mounted back hoe carefully operating from the river bank and in the river where necessary. All sediment removed from the river and materials removed from the existing dam shall be hauled off and disposed off-site.
