Question No. 2: Are all listed subcontractors required to have a DUNS #?

Response to Question No. 2: No, not for this project.

Question No. 3: Also, in the Instruction to Bidders, Section M Subcontracting, Page 9, regarding the 1% subcontractor list it states we need to list the subs license classification and anticipated amount of the subcontract. I do not see a space for this on the subcontract list provided, where should we list this information?
