RANGE FOR ENGINEER'S ESTIMATE: \$150,000.00 - \$200,000.00

PROJECT SCOPE: Truckee Meadows Water Authority (TMWA) is accepting sealed bids for Cla-Val parts for the replacement of existing roll seal valves. Varying sizes, types, pressure ratings and quantities of Cla-Val parts will consist of an epoxy-coated ductile iron body with stainless steel internal trim and buna rubber components. All components furnished shall be new material of proven ability and must meet NSF 61 specifications.

MANDATORY PRE-BID CONFERENCE: **Not required for this Project.**

BID SUBMITTAL: Sealed bids must be submitted to TMWA by mail to P.O. Box 30013, Reno, Nevada 89520-3013 or in person to 1355 Capital Boulevard, Reno, NV 89502, and must be **RECEIVED BY TMWA NOT LATER THAN 10:00 A.M. on June 16, 2016**. Bids received after the date and time set for receipt will be **REJECTED**.

BID OPENING: **June 16, 2016, 10:05 a.m.** at the TMWA Conference Room, 1355 Capital Blvd., Reno, NV 89502. TMWA reserves the right to reject any or all bids, including without limitation the right to reject any or all nonconforming, non-responsive, unbalanced, or conditional bids, and to reject the bid of any bidder if TMWA believes that it would not be in the best interest of TMWA to make an award to that bidder. TMWA also reserves the right to waive informalities. Bids will be evaluated as prescribed in Nevada Revised Statute 332.

AWARD DATE: On or Before July 1, 2016.

COMPLETION DATE: Three Hundred Sixty-Five Days following issuance of the Notice to Proceed.

DELIVERY DATE: Orders will be placed on multiple dates throughout the contract period. Delivery within four (4) weeks of order date.

SHIPPING AND DELIVERY: Total bid price shall include delivery but not shipping. Delivery shall be to the TMWA Glendale Water Treatment Plant located at 1205 S. 21st Street, Sparks, Nevada 89431. TMWA may exercise its discretionary option for TMWA representative to pick up the Cla-Val(s) at will call.

PLANS AND SPECIFICATIONS: Not Applicable.

Bidders are to complete all Bid Submittal Forms, contained on pages 2-11 in the Bid Proposal Form Section of the Bid Documents. The complete Contract Documents must be submitted to comprise a responsive and responsible bid. **A bid bond will not be required for this project.** Addenda, if any, shall be posted on the TMWA web-site at http://www.tmwa.com/about_us/doingbusinesswithtmwa/ It is each bidder's sole responsibility to ensure that they have received all addenda prior to submission of their bid.

TERM OF CONTRACT: One year with the right to renew for up to four (4) additional one-year renewal periods for a total of five (5) years.
