**PROJECT SCOPE:** The Site of Work for the Stead Main Replacement Phase 2 project is located in Reno, Nevada. Truckee Meadows Water Authority (TMWA) is accepting sealed bids for all labor, materials, equipment, and incidentals required for the installation of approximately 11,881 linear feet of 20-inch diameter restrained joint and non-restrained joint ductile iron water main, complete with all required valves, fittings, and appurtenances; connection to existing water mains; construct a pressure regulating station; removal of existing structures and facilities; demolition of an existing booster pump station; grout filling of existing water mains; permanent asphalt concrete patching.

TMWA will provide and has selected a consultant to provide backfill and compaction testing.

The Contractor shall provide any necessary surveying.

TMWA will provide project control and survey reference points.

**MANDATORY PRE-BID CONFERENCE AND OPTIONAL SITE VISIT:** A mandatory pre-bid conference will be held on **December 21, 2016 at 10:00 a.m.** at the TMWA Conference Room, 1355 Capital Blvd., Reno, NV 89502. An optional site visit will take place immediately following the Pre-Bid Conference. Any prospective bidder arriving **after** 10:00 a.m. shall be considered **late** and shall not be permitted to attend the conference; and a bid proposal **will not** be accepted from such bidder. **TMWA will accept and entertain bids from only those Bidders in attendance at the Pre-Bid Conference. NO EXCEPTIONS MADE.**

**BID SUBMITTAL:** Sealed bids must be submitted to TMWA by mail to P.O. Box 30013, Reno, Nevada 89520-3013 or in person to 1355 Capital Boulevard, Reno, NV 89502, and must be **RECEIVED BY TMWA NOT LATER THAN 2:00 P.M. on January 10, 2017.** Bids received after the date and time set for receipt will be **REJECTED.**

**BID OPENING:** **January 10, 2017, at 2:05 p.m.** at the TMWA Conference Room, 1355 Capital Blvd., Reno, NV 89502. TMWA reserves the right to reject any or all bids, including without limitation the right to reject any or all nonconforming, non-responsive, unbalanced, or conditional bids, and to reject the bid of any bidder if TMWA believes that it would not be in the best interest of TMWA to make an award to that bidder. TMWA also reserves the right to waive informalities. Bids will be evaluated as prescribed in Nevada Revised Statute 338.147.

Proposals must be submitted on the stapled bid proposal package to be considered a responsive and responsible bid. Truckee Meadows Water Authority will not consider a Bid received if there is an omission of or failure to complete any portion of the required documents prior to the time of Bid Opening. Do not submit the entire bid book. Each bid shall be accompanied by a certified or cashier's check or bid bond in the amount of not less than five percent of the amount bid in the proposal.
