

## TMWA END USER DATA AGREEMENT

The Nevada State Assembly passed "Assembly Bill No. 441" (an act relating to Homeland Security). In Section 7, the **Truckee Meadows Water Authority** is defined as a "Governmental Utility". Maps, plans, paper or electronic drawings, and records showing TMWA's infrastructure are defined as "Restricted Documents" in Sections 10.3, 21.1 and 22.1.

## **Use Limitations:**

**End User may:** use the Data solely for the following internal permitted purposes: (a) reformatting for internal purposes; (b) making one (1) copy for internal archival or backup purposes; (c) making Data available to consultants, End Users or other agents doing internal, project specific work for End User; (d) utilization on an isolated, project specific basis, non-manipulated as to format, in development of a product or service for singular third party benefit (i.e., backdrop for a project design, or as information to support an economic development siting analysis).

End User agrees not use nor permit any other party to use Data provided by TMWA for any purpose other than as permitted herein and other than subject to the limitations provided herein. As used herein, the term "Data" shall mean any data, maps, plans, paper or electronic drawings, documents, or written materials provided to End User by TMWA in connection with this Agreement. Said "Data" is considered confidental and is defined as "Restricted Documents" and may not be copied, duplicated, or reproduced by unauthorized persons.
