TRACKING OUR WATER SUPPLY

As the region's largest water purveyor,
TMWA monitors our community's water supply on a daily basis.
With each winter storm our water supply continues to improve and snowpack conditions



in the Sierra are in great shape right now. While we cannot predict weather conditions for the rest of the season, we are in a very solid position for this time of year and the outlook for this summer's water supply is looking good. Fortunately, we have been able to meet the water needs of our customers without having to dip into any of our upstream drought storage reserves. You can monitor river flows and the level of our largest reservoir, Lake Tahoe, in real time at www.tmwastorage.com.
