STANDING ADVISORY COMMITTEE NEEDS VOLUNTEERS:

The Standing Advisory Committee (SAC) is seeking volunteers for its oversight committee. SAC members review budgets, rates, proposals, and other items; read reports and provide feedback from the customer perspective. The committee reports its findings and makes recommendations to TMWA's board of directors.

This volunteer committee meets the first Tuesday of each month at 3:00 p.m. Those interested in serving on the SAC must be TMWA customers. Applications to serve on the committee can be submitted via letter or e-mail and must be received by Friday, Dec. 2, 2016. Applications should include the following:

- Applicant's name and contact information
- Type of customer or group represented (multi-family residential, single-family residential, commercial or irrigation)
- Statement of interest in serving on the SAC
- Any pertinent experience (financial, economic, engineering, water resource management, etc.)

TMWA DROUGHT RESPONSE PROJECTS: PROTECTING WELLS AND USING SURFACE WATER WHEN POSSIBLE

The consolidation of Washoe County Water Resources and TMWA in 2015 has created many opportunities for improving conjunctive use of our water resources throughout the Reno-Sparks area. "Conjunctive use" means using surface water from the Truckee River whenever possible and resting and recharging wells in critical areas.

The \$4 million Arrowcreek Drought Response Phase 1 Project was brought online in April 2016. By pumping a supplemental water supply to the upper reaches of the Mt. Rose alluvial fan area, TMWA has been able to significantly decrease groundwater pumping from the Mt. Rose and Arrowcreek wells. In the May– August 2016 time frame, pumping from wells in the Arrowcreek and Mt. Rose systems decreased by 495 acre-feet (161.6 million gallons) when compared to the same period in 2015 (a 42 percent reduction). These new facilities will allow TMWA to implement a conjunctive-use plan in the Mt. Rose and Arrowcreek systems this winter by serving the area with treated surface water and turning off the wells for an extended period of time.

TMWA has completed the North Valleys Integration Project, which involved building the 24-inch Lemmon Drive Main and 18-inch North Virginia Main. The \$10 million project, which was completed significantly under budget, adds the capacity to utilize the Fish Springs groundwater resource in the North Valleys, should the drought continue.

TRUCKEE RIVER FUND ADVISORS APPROVE SIX PROJECTS THAT IMPROVE AND PROTECT OUR WATERSHED

The Truckee River Fund (TRF) is working year round to protect our water quality and watershed. It was established by TMWA in 2005 to protect and enhance the water quality of the Truckee River. The Fund researches and finances projects that protect the water quality or water resources of the Truckee River and its watershed, which benefits the community's primary water source and TMWA customers. Every project is required to provide matching grants, thus maximizing the impact of TMWA's contribution. Since its inception, more than \$9 million has been approved for distribution from the fund to 138 qualifying projects, with over \$16 million in matched funds.

Recently funded projects include: Donner Creek Bank Stabilization, Donner Creek Concept Designs, Watershed Education Initiative, One Truckee River Phase I Implementation—AmeriCorps Support, Watershed Survey & Education, Webber Lake—Little Truckee River Headwaters Management, Spring Invasive Weed Pull, and Fall Truckee River Cleanup.
