**PROJECT SCOPE:** Truckee Meadows Water Authority (TMWA) is accepting sealed bids for all labor, materials, equipment, and incidentals required for the 2017-2018 Pressure Regulator Improvements. The Site of Work are located throughout the Cities of Reno, Sparks and Washoe County, Nevada. The Work consists of the installation of two new pressure reducing stations (PRS's); rehabilitates two existing PRS's; and abandons one existing PRS. Three of the PRS sites involve varying levels of abandonment and/or demolition. The total project installs approximately 680 LF of 8" & 6" restrained joint ductile iron pipe. Minor portions of the project include but are not limited to; a poured in place concrete vault; electrical work; sidewalk, curb, gutter, pavement, and site restoration.

TMWA will provide and has selected a consultant to provide backfill and compaction testing.

Bids received after the date and time set for receipt will be **REJECTED**.

**BID OPENING:** **January 9, 2018, at 2:05 p.m.** at the TMWA Conference Room, 1355 Capital Blvd., Reno, NV 89502. TMWA reserves the right to reject any or all bids, including without limitation the right to reject any or all nonconforming, non-responsive, unbalanced, or conditional bids, and to reject the bid of any bidder if TMWA believes that it would not be in the best interest of TMWA to make an award to that bidder. TMWA also reserves the right to waive informalities. Bids will be evaluated as prescribed in Nevada Revised Statute 338.147.

The bid proposal package comprised of the: Bid Bond, Bid Schedules, Local Preference Affidavit (if applicable) and Acknowledgement and Execution is stapled and found in the inside front cover of the Contract Documents/Specifications. Proposals must be submitted on the stapled bid proposal package to be considered a responsive and responsible bid. Truckee Meadows Water Authority will not consider a Bid received if there is an omission of or failure to complete any portion of the required documents prior to the time of Bid Opening. Do not submit the entire bid book. Each bid shall be accompanied by a certified or cashier's check or bid bond in the amount of not less than five percent of the amount bid in the proposal. It is each bidder's sole responsibility to ensure that they have received all addenda prior to submission of their bid.
