# SMART ABOUT WATER QUICK FACT:

How do new houses and developments get water service? In order to receive water service, every residence and business in the Truckee Meadows must have dedicated rights (about ½ acre-foot per year, per household).

The total number of water rights on the Truckee River was fixed with the Orr Dich Decree in 1944. That number of water rights has remained fixed since then. Water rights are obtained on the open market, and water rights for development in the Truckee Meadows are usually converted from agricultural/irrigation use to municipal use.

# AN UPDATE ON OUR WATER SUPPLY:

For those who have lived in the Truckee Meadows for some time, we know that Mother Nature delivers an unpredictable mix of normal, dry and big snowpack years. So far this year, it has been a lackluster winter. The big winter storms needed for our snowpack just haven't materialized yet. As of this printing, preliminary streamflow runoff forecasts for this spring are significantly below normal in both the Lake Tahoe and Truckee River watersheds. (Springtime snowmelt runoff is captured and stored in upstream reservoirs and used to provide river flows throughout the year.)

The good news is that the Reno-Sparks area is still benefitting from last year's record snowpack and runoff. How does that help us this year? All Truckee River reservoirs on the system filled and spilled last year and are presently still at their maximum legal capacity. TMWA stores water in Lake Tahoe, Donner and Independence lakes, as well as in Boca, Stampede and Prosser reservoirs. Because of last year's historic runoff, normal Truckee River flows are expected for another two years, making the water supply outlook for the region excellent. While we only use approximately 3% of the Truckee River, the water we take makes up about 85 percent of our total supply in a typical year.

A recent, major accomplishment that profoundly improved the future of our water supply is the Truckee River Operating Agreement (TROA). Finalized in December of 2015, TROA protects our area by providing additional operational flexibility of the Truckee River. For example, if drought conditions worsen TMWA is allowed to store additional amounts of water upstream each year to meet the demands of our water customers. Learn more at tmwa.com/troa.
