

**INVITATION TO BID

STMGID WELL BYPASS IMPROVEMENTS**

RANGE FOR ENGINEER'S ESTIMATE: \$210,000.00 - \$260,000.00

PROJECT SCOPE: Truckee Meadows Water Authority (TMWA) is accepting sealed bids for all labor, materials, equipment, and incidentals required for the STMGID Well Bypass Improvements project. The Work will occur at three of TMWA's well sites located in Washoe County, Nevada. The Work consists of interior and exterior piping modifications and additions, trenching, backfill, drainage improvements, construction of a sodium hypochlorite storage room, reinforced concrete, electrical, HVAC, and demolition of existing facilities. TMWA has selected a material and compaction testing, special inspection, and quality assurance consultant at no cost to the Contractor. Contractor will be required to perform any necessary construction survey staking.

MANDATORY PRE-BID CONFERENCE and SITE VISIT: A mandatory pre-bid conference and site visit will be held on **July 11, 2018, at 10:00 a.m.** at the TMWA Conference Room, 1355 Capital Blvd., Reno, NV 89502. Any prospective bidder arriving **after 10:00 a.m.** shall be considered **late** and shall not be permitted to attend the conference; and a bid proposal **will not** be accepted from such bidder. A **mandatory site visit will take place immediately following the mandatory pre-bid conference.** TMWA will accept and entertain bids from only those Bidders in attendance at the mandatory pre-bid conference and mandatory site visit. **NO EXCEPTIONS MADE.**

BID SUBMITTAL: Sealed bids must be submitted to TMWA by mail to P.O. Box 30013, Reno, Nevada 89520-3013 or in person to 1355 Capital Boulevard, Reno, NV 89502, and must be **RECEIVED BY TMWA NOT LATER THAN 2:00 P.M. on July 25, 2018.** Bids received after the date and time set for receipt will be **REJECTED.**

BID OPENING: **July 25, 2018, at 2:05 P.M.** at the TMWA Conference Room, 1355 Capital Blvd., Reno, NV 89502. TMWA reserves the right to reject any or all bids, including without limitation the right to reject any or all nonconforming, non-responsive, unbalanced, or conditional bids, and to reject the bid of any bidder if TMWA believes that it would not be in the best interest of TMWA to make an award to that bidder. TMWA also reserves the right to waive informalities. Bids will be evaluated as prescribed in Nevada Revised Statute 338.147.

ANTICIPATED START DATE: On or Before August 13, 2018.

COMPLETION DEADLINE: November 30, 2018.

The cost for all bid documents is non-refundable. A \$250.00 deposit is required due to Homeland Security issues before any Bid Documents may be purchased. Complete plans and specifications must be returned to TMWA within thirty (30) days of Bid Opening or the deposit will be forfeited.

The bid proposal package comprised of the: Bid Bond, Bid Schedules, Local Preference Affidavit (if applicable) and Acknowledgement and Execution is stapled and found in the inside front cover of the Contract Documents/Specifications. Proposals must be submitted on the stapled bid proposal package to be considered a

responsive and responsible bid. Truckee Meadows Water Authority will not consider a Bid received if there is an omission of or failure to complete any portion of the required documents prior to the time of Bid Opening. Do not submit the entire bid book. Each bid shall be accompanied by a certified or cashier's check or bid bond in the amount of not less than five percent of the amount bid in the proposal. Addenda, if any, shall be posted on the TMWA website at <https://tmwa.com/doing-business-with-us/bidding-opportunities/>. It is each bidder's sole responsibility to ensure that they have received all addenda prior to submission of their bid.
