## SMART ABOUT WATER QUICK FACT:

How do new houses and developments get water service? To receive water service, water rights for the project must be dedicated to TMWA before building can begin. New residential projects require about ½ acre-foot, per household. For every acre foot of surface water needed for new developments, another 11 percent (or 0.11 acre-feet) must be dedicated for drought storage.

Water rights are obtained on the open market. The total number of water rights available on the Truckee River was set in 1944 (codified by the Orr Ditch Decree), and that number of water rights has remained unchanged since then. Most water rights used for development in the Truckee Meadows are converted from agricultural/irrigation use to municipal use.

Sierra Nevada Journeys will be on site with watershed activities for kids who can also become scientists for the day at TMWA's interactive water-quality testing station. TMWA's big rigs will also be on display, for kids to explore. In addition, tree tours will be scheduled all day featuring Reno's beautiful trees and how to care for them.

If learning about our water system leaves you hungry, don't worry; several local food trucks will be on site serving an array of delicious cuisine and treats during the event.

## HOW CAN YOU IDENTIFY TMWA EMPLOYEES?

With the watering and construction season coming, there will be more TMWA employees working in the community. Customers often ask us how they can be sure these workers are really TMWA employees. Please be aware that:



All of our vehicles are clearly marked with the TMWA logo.



Our personnel always carry a security badge. We encourage customers to ask anyone presenting themselves as a TMWA employee for his/her badge if it is not clearly visible. If the individual does not produce a badge, he/she is not a TMWA employee.



In very rare instances, TMWA employees may ask if they can take a sample of your water. However, TMWA will never request or accept a payment at your home.

If you receive an unsolicited telephone call asking for a payment on your TMWA account, please take down the telephone number, refuse to make the payment, and notify TMWA directly at (775) 834-8080. The only valid methods for paying your TMWA bill are listed at www.tmwa.com, and the only valid telephone number for paying over the phone is TMWA's main customer service line at (775) 834-8080. If you are concerned about someone who has approached you or called your home regarding your water service, please call us at (775) 834-8080.
