Notice is hereby given that a Public Workshop will be conducted on adoption of the Truckee Meadows Water Authority 2035 Water Facility Plan update at 5:30 p.m. Wednesday, May 29, 2019 at the offices of the Truckee Meadows Water Authority, 1355 Capital Blvd, Reno, Nevada. The updated Water Facility Plan reflects the outcomes of routine engineering analyses associated with revised growth projections presented in Authority's latest Water Resource Plan for the 20-year planning period of 2015-2035.

The 2035 Water Facility Plan includes proposed revisions to Authority's maximum day demand projections and Capital Improvement Plan. These revisions will be reflected in the routine recalculation and updating of fees to be paid by new development to reimburse the Truckee Meadows Water Authority for capital investment in water system facilities which provides capacity to serve growth. The Second Reading/Public Hearing will be conducted on those Rate revisions during the Truckee Meadows Water Authority Board meeting at 10 a.m. Wednesday, June 19, 2019 at the Sparks Council Chambers, 745 Fourth St., Sparks, Nevada. If adopted, the revisions would become effective at the start of business, Monday, July 1, 2019, or such other date established by the Board.
