Notice is hereby given that a Public Workshop will be conducted on proposed amendments to the Truckee Meadows Water Authority development fees set forth in Rate Schedule BSF – Business Services Fees and Rate Schedule WSF – Water System Facility Charges (including Area Facility Unit Costs by Charge Area) at 5:30 p.m. Wednesday, April 24, 2019 at the offices of the Truckee Meadows Water Authority, 1355 Capital Blvd, Reno, Nevada. Proposed amendments to Rate Schedule BSF reflect the routine updating of fees associated with an application for new or modified water service including engineering review, inspection services and other services provided as part of the new business process. Proposed amendments to Rate Schedule WSF – Water System Facility Charges reflect the routine recalculation and updating of fees to be paid by new development to reimburse the Truckee Meadows Water Authority for capital investment in water system facilities which provides capacity to serve growth. Water System Facility Charges were last updated in 2013.

Notice is hereby given that a First Reading/Public Hearing will be conducted on the above described Rates revisions during the Truckee Meadows Water Authority Board meeting at 10 a.m. Thursday, May 23, 2019 at the Sparks Council Chambers, 745 Fourth St., Sparks, Nevada. The amendments are proposed to become effective at the start of business, Monday, July 1, 2019, or such other date established by the Board.
