Dan Nubel, TMWA Staff Attorney, provided an update on the status of bills.

Leo Drozdoff, TMWA Government Affairs Consultant, informed the subcommittee that AB104 was heard in committee and staff provided testimony in support of the bill.

Stefanie Morris, TMWA Outside Counsel, reported on AB419, which was just introduced this week. Ms. Morris explained that TMWA provided edits and comments to the author that discussed staff's concerns. Staff did not request the Subcommittee to take action today.

The Subcommittee discussed the details of the bill and requested staff keep them informed if the bill is scheduled to be heard or if there are any amendments introduced.

Lucas Foletta, WRWC General Counsel reported that staff are also monitoring SB276, regarding the unauthorized discharge into state waters and reporting requirement to the Division of Environmental Protection, as well as notifying other affected governmental entities or tribes.
