FLEISH PENSTOCK REPLACEMENT**

RANGE FOR ENGINEER'S ESTIMATE: \$1,627,000.00 - \$2,009,000.00

PROJECT SCOPE: Truckee Meadows Water Authority (TMWA) is accepting sealed bids for all labor, materials, equipment, and incidentals required for the Fleish Penstock Replacement. The Site of Work is located in Verdi, Nevada. The Work consists of furnishing all labor, materials, equipment, and incidentals required for the demolition of the existing 360-foot long riveted steel penstock piping to the Fleish hydroelectric plant, and replacing it with a new 96-inch diameter penstock and related connections and appurtenances. The Work will include extensive excavation, steel pipe purchasing, lining and coating of the pipe, welding, concrete and gunite, and some electrical work. Also included are improvements at the Steamboat Ditch crossing, and miscellaneous site improvements.

TMWA will provide and has selected a consultant to provide backfill and compaction testing.

The Contractor shall provide any necessary surveying.

NO EXCEPTIONS MADE. MANDATORY SITE VISIT** immediately following the Pre-Bid Conference.

BID SUBMITTAL: Sealed bids must be submitted to TMWA by mail to P.O. Box 30013, Reno, Nevada 89520-3013 or in person to 1355 Capital Boulevard, Reno, NV 89502, and must be **RECEIVED BY TMWA NOT LATER THAN 3:00 P.M. on August 26, 2016.** Bids received after the date and time set for receipt will be **REJECTED.**

BID OPENING: August 26, 2016, at 3:05 p.m. at the TMWA Conference Room, 1355 Capital Blvd., Reno, NV 89502. TMWA reserves the right to reject any or all bids, including without limitation the right to reject any or all nonconforming, non-responsive, unbalanced, or conditional bids, and to reject the bid of any bidder if TMWA believes that it would not be in the best interest of TMWA to make an award to that bidder. TMWA also reserves the right to waive informalities. Bids will be evaluated as prescribed in Nevada Revised Statute 338.147.

The cost for all bid documents is non-refundable. A \$250.00 deposit is required due to Homeland Security issues before any Bid Documents may be purchased. Complete plans and specifications must be returned to TMWA within thirty (30) days of Bid Opening or the deposit will be forfeited.

The bid proposal package comprised of the: Bid Bond, Bid Schedules, Local Preference Affidavit (if applicable) and Acknowledgement and Execution is stapled and found in the inside front cover of the Contract Documents/Specifications. Proposals must be submitted on the stapled bid proposal package to be considered a responsive and responsible bid. Truckee Meadows Water Authority will not consider a Bid received if there is an omission of or failure to complete any portion of the required documents prior to the time of Bid Opening. Do not submit the entire bid book. Each bid shall be accompanied by a certified or cashier's check or bid bond in the amount of not less than five percent of the amount bid in the proposal. It is each bidder's sole responsibility to ensure that they have received all addenda prior to submission of their bid.
